# TC1 EMC Management Meeting – 2023 EMC-SIPI Symposium Friday, Feb 10, 2023, 11:00 a.m. CDT (UTC-5)

## • 2023 Symposium

- a. Paper submissions
  - i. Paper reviews for the symposium are currently in progress. 4 papers from TC1 are currently in the pipeline.
  - ii. No update on workshops & tutorials
  - iii. Action: Tom to receive a copy of spread sheet with dates, paper submissions and Technical Committees involved.
  - iv. Action: Karen to check about the standards relevant to ham radio operators
- Status of TC1 special committee reviewing iNARTE accreditation status (Tom Braxton)
  - a. American Council of Independent Laboratories (ACIL) has sent a letter to the IEEE EMC board of directors & executives of exemplar global concerning the termination of MoU. This was discussed in the board of directors meeting 2 days ago.
  - b. Tom has provided a response to ACIL's letter with justification.
  - c. The Outlines for qualifications, topics of examination, mechanism to keep the certification current are developed.
  - d. The package of recommendation to the Board of directors is slated to be submitted before the deadline of March 10<sup>th</sup>.
- EMC training updates on demo circuit-board construction (Louann Mlekodaj, Tom Fagan. Randy Jost)
  - a. This work is progressing well. Currently a plan is being developed for some demonstrations of the boards.
  - b. Overall, the intent of this activity is to create a set of tools for EMC training to demonstrate common EMC phenomena. The designs for the boards and software would be made freely available in GitHub while the physical boards may be made available at schools, universities, companies etc.,
- Follow-up on new training ideas (mid-career, Global University, etc.) discussed in Spokane
  - a. This task's intent is to curate the available courses and training offered by independent consultants as a technical society.
  - b. An idea was brought about mid-career engineers taking up amateur radio operator license as an opportunity to enhance their learning and development experience.
  - c. IEEE does have an amateur society club. Interested members can consider learning more about it and join.

#### • TC1 support for the ELISE program studying EMC resilience (Davy Pissoort)

- a. No update on this topic this week.
- b. This topic in a nutshell is a research program intended to study the EMC effects and mitigation by academic research teams. This involves topics pertaining to EM resilience. (Note: kindly refer to past meeting notes for a detailed description of this topic)
- c. This is one of the 3 research programs called PETER , ETERNITY and ELISE. All three are not entirely about EMI risk.
- d. At this stage PETER program is approaching the finish line while ETERNITY program is starting. The ELISE program on the other hand is about to get started.
- 1848 for Railways standard development update (Keith Armstrong)
  - a. The overall objective of this standard can be summarized as *Managing Risks caused by EMI*. (Note: Kindly refer to past meeting notes for detailed description of the standard)
  - b. No update about the Railway PAR submitted by Joe Cosgrave.
  - c. Action: Tom to touch base with Joe Cosgrave or Jennifer about the PAR submission.

- d. The team developing the Machinery specific component of this standard is making good progress.
- e. Regarding the medical devices, Keith has recently submitted a draft to IEC TR 60601-4 series.
