1 Welcome and introductions

Don Heirman, the Chair of SC1 opened the meeting and emphasized that SC1 is a coordinating committee with the intention to work with other technical committees with regard to the Smart Grid. ACTION ITEM 2016-1: Bill Radasky to draft a table that indicates the member names and which years they attended the SC 1 meetings. [CLOSED during meeting]

The rest of the action items were reviewed, and several were kept as they were felt to be important to resolve. All of the responsible persons were present and agreed to work on their respective actions as listed below:

ACTION ITEM 2015-2: Bill Radasky to send memorandum to the Convener of SC77B/MT12 (about lack of commercial couplers for IEC 61000-4-18) [OPEN]

ACTION ITEM 2015-3: Secretary of SC1 to revise web pages to update coordination with other technical committees [OPEN]

ACTION ITEM 2015-6: Bill Radasky to contact TC13 to find out their procedures for their defined test methods for EMC to find out how to load Smart Meters during testing [OPEN]

ACTION ITEM 2016-2: Don Heirman to collect paper ideas from SC1 members to use in a new column in the EMC Society magazine making the reader aware of the activity of SC1 [OPEN]

ACTION ITEM 2016-3: Abtin Spantman will prepare a short description of the planned work. To measure the harmonics generated by in-feed converters and other rectifiers. [OPEN]

ACTION ITEM 2016-4: SC 1 members will provide comments back to Mr. Spantman after completion of 2016-3 [OPEN]

4 New projects proposals

There was a discussion about any future projects that SC1 should undertake in the future. It was thought to be a good idea to look into other IEEE Smart Grid activities including the IEEE 2030 activities and possibly to identify a liaison with them. Also, there was mention of IEEE 1547 on interoperability.

ACTION ITEM 2017-1: Don Heirman to investigate the IEEE 2030 activity to see if there is information that can be provided to SC1

5 SG coordination with EMCS TCs

The Chair, Don Heirman will review commitments from other IEEE EMC Technical Committees to participate in SC1 activities.

ACTION Item 2017-2: Don Heirman will ask TC chairs for any Smart Grid activity they may have.

6 Review of meeting action items

No further action items were added other than the Chair's plans as indicated in Clauses 4 and 5 of these minutes.

7 AOB

As it was not anticipated at this meeting that we would have a volunteer for Secretary of SC1, an election of a new Secretary was taken under any other business. Dr. Iliana Nicolae volunteered to become Secretary of SC1 and after a short discussion, a vote was taken by the members in attendance. The vote was unanimous, and SC1 welcomes Iliana as our new Secretary. Since SC1 elects officers for 3-year terms and the current Chair and Vice Chair were elected at last year's meeting, it therefore was agreed that the Secretary would serve a 2 year term ending on 31 December 2019 so that all officer elections will be at the same time.

8 Next meeting

In 2018 the IEEE EMC Symposium will be a joint symposium with APEMC in Singapore from 14-17 May 2018, and there will be a separate national conference in Long Beach, CA from 30 July to 3 August 2018. It was decided that SC1 meetings would be held at both locations to allow a better opportunity for attendance by interested parties throughout the world. It is likely that SC1 will also organize a workshop in Singapore.
